Vendor Application Process

Prospective vendors must fill out a yearly application, be visited by the OFM Market Manager or other representative of OFM. Vendor applications will be reviewed and accepted at the discretion of the OFM market management. After your application is received, we will review it. If you are approved, the Mkt. Mgr. will contact you to schedule a visit to your farm. The purpose of this visit is to confirm that the items you wish to sell are indeed locally grown by you. We do not judge your farm or farming practices. This process gives market shoppers confidence in you, your products, and the market itself. The application fee of \$20 is due at the time of the visit. It helps to offset the travel costs of this visit.
